### **Factioned and Weakened Al-Shabaab Becoming Desperate**

### Al-Shabaab abducting children from central Somalia

- Al-Shabaab in recent weeks has kidnapped hundreds of children from the militant-controlled town of El Bur in Galgadud, residents say, expressing fear that the al-Qaeda-affiliated group is forcibly recruiting them as child soldiers.
- Since early May, more than 350 children under the age of 16 have been taken from Qur'an schools or while playing in the streets of El Bur and surrounding areas
- According to a May 15th report to the United Nations Security Council from UN Secretary-General Ban Ki-moon, al-Shabaab perpetrated 1,789 cases of child recruitment in 2012, while the Somali National Army was responsible for 179 similar cases.

- Hassan Dahir Aweys a high ranking Al Shabaab official has reportedly fled southern Somalia seeking refuge in central Somalia after an Al Shabaab feud has intensified
- Sources speculate, that Aweys fled the assassination squad sent by Godane, and is currently regrouping in Mudug region.

- After rival al-Shabaab forces squared off in a deadly battle last week in the Lower Shabelle town of Barawe, residents of militant-controlled areas say al-Shabaab's feuding factions are preparing for more open warfare
- Forces loyal to top al-Shabaab commander Ahmed Abdi Godane, also known as Mukhtar Abu Zubayr, and second-in-command Ibrahim al-Afghani faced off beginning late night on June 19th, Barawe
- Barawe residents long expected clashes between al-Shabaab fighters because law and order in the town had deteriorated to the point where militants from rival factions would argue and point their AK-47s at one another regularly

# Top Al Shabaab official caught days after fleeing infighting

- Al Shabaab official Hassan Dahir Aweys on the US most wanted terrorist list has been reportedly captured in the town of Adaado on Wednesday after fleeing Al Shabaab infighting in southern Somalia
- · A group of armed pirates captured the Al Shabaab leader in the Himan and Heeb area in Galgudud region. The former Hizbul Islam Chief, Hassan Dahir Aweys was making his way reportedly to the pirate strongholds of Hobyo and Harardheere
- The pirates in the area handed the wanted terrorist over to the Himan and Heeb administration in the area.
- Ethiopia and the U.S. are also requesting his handover as they are concerned about a judicial hearing of such a high ranking Al Shabaab official.



 The United States Treasury Department's Office of Foreign Assets Control (OFAC) added him to the Specially Designated Global Terrorist (SDGT) on November 7, 2001. The UN also designated Aweys as a terrorist calling him "an individual associated with Al Qaeda".

# Al Shabaab official Aweys capture 'big test' for Somalia govt anti-terrorism policy

- The method that Somali President Hassan Sheikh Mohamud's administration deals with the capture of Aweys will be indicative of the president's anti-terrorism policy.
- The Somali Federal Government is "leaning towards accommodating Aweys" and empowering him to fight Al Shabaab in the central regions of Galgadud and Hiran, while Somali Federal Government plans to "deploy troops in Middle Jubba region bypassing Al Shabaab-held areas like Barawe in new efforts to destabilize Jubaland administration in Kismayo,"
- Jubaland leaders have previously accused the Somali government of "cooperating with Al Shabaab" to foment violence in Kismayo.


- Al Shabaab militant group in Somalia has publicly admitted killing two senior officials, underscoring the growing violent dispute within the militant group
- This development marks the growing violent dispute within Al Shabaab ranks, as Al Shabaab chief Ahmed Abdi Godane is fighting former comrades for domination of Al Shabaab group.
   Ibrahim Afghani was Godane's deputy and was wanted by the U.S. government with a US\$7million bounty.

- Rival clan militias fighting in Kismayo, Somalia, earlier this month caused an unknown number of civilian casualties in apparently indiscriminate attacks on civilian buildings
- "The militias fighting over Kismayo showed little apparent regard for the safety of civilians around them, including at a market and a medical clinic," said Leslie Lefkow, Africa deputy director. "All warring parties should take precautions to spare the civilian population. The laws of war apply to all armed groups."



• International humanitarian law, or the laws of war, obliges all parties to a conflict, including state armed forces and non-state armed groups, to take every feasible precaution to minimize harm to the civilian population. Attacks that target civilians or civilian objects are prohibited, as are attacks that do not discriminate between civilians and military objectives, or are expected to cause civilian harm greater than the anticipated military gain.

- The Special Representative of the Secretary-General (SRSG) for Somalia, Nicholas Kay, today
  urgently called for an immediate cessation of hostilities as armed clashes flared up again in
  Somalia's southern port city of Kismayo among groups claiming leadership over the "Jubbaland"
  regional administration
- "At the same time as this new fighting has broken out, contacts are underway to put together an inclusive process to defuse tensions. The details are being worked out. This is not the time to engage in violence which will entrench positions and make it all the harder to achieve a settlement and begin reconciliation. I call on all parties to refrain from any action which could be seen as a provocation, and call for an immediate cessation of hostilities", SRSG Kay said in a press release.
