- Puntland security officials wounded and captured a suspected al-Shabaab official in a shootout that also killed a civilian
- The suspect is the alleged chief of al-Shabaab's assassin ring, Amniyat, said Puntland regional Minister of Security Khalif Isse Mudan
- Mudan said that at the time of the arrest, the suspect was with other suspected al-Shabaab members who are now being pursued by police.

- Across Somalia, the noose is tightening on al-Shabaab. The radical Islamic militia, which once
 controlled almost all of Mogadishu and southern Somalia, is on the defensive these days as it
 steadily loses ground to Western-backed forces
- Al-Shabaab's decline over the past two years is linked to the invading Kenyan troops in southern
 Somalia and an African military coalition in Mogadishu
- Ahmed Abdi Godane, the shadowy and reclusive leader of Somalia's biggest terrorist group, has a United States \$7-million bounty on his head and even his family is not safe pressure

- The colonel added that the region where the fighting occurred is in the safe hands of the federal government troops

Al Shabaab Display Kenyan Hostages in Main Square

- Two Kenyan hostages were displayed in a public square in Jilib 113 KMs north of Kismayo.
- The two Kenyans were allegedly taken hostage last month when Al Shabaab fighters attacked a border post killing five.
- Witnesses of the public display who spoke to media said that the two hostages were in dire conditions
- Last September, Kenyan and Somali forces took the lucrative port of Al Shabaab in the lower Jubba region, their main source of income.

Recent Crimes By Al-Shabaab Show Contempt for Sharia

- Al-Shabaab militants have carried out a string of brutal attacks and crimes against civilians in recent weeks -- kidnapping, beheading and robbing Somalis in complete disregard of the sharia law the group purports to uphold
- Al-Shabaab's punishments are arbitrary and hypocritical, as militants found guilty of crimes do
 not have to suffer the prescribed punishments; militants have also launched reprisals against
 Somali civilians, including kidnapping or beheading relatives of officials from Gedo and Hiran



- In Hiran, al-Shabaab has been issuing orders that have no relation to sharia so its members can get away with robbery and adultery, said Hiran police chief Colonel Isaaq Ali Abdullahi.
- Al-Shabaab's judges do not possess a full understanding of Islamic jurisprudence and the tenets of a fair and impartial justice system, he said. Their judgements are invalid because they are politically motivated, vengeful and based on a complicit justice system, he said.
- Neither sharia law nor international law sanctions kidnapping, El Waq district commissioner
 Sahal Malim Ali said. In combat, wartime rules of engagement apply to captured enemy
 combatants, but holding civilians as captives is an unjust, illegitimate and unacceptable tactic for exerting pressure, he said.

Fighting Breaks Out in Kismayu

Raskamboni, Tribal Militias Battle in Kismayo

- Heavy fighting broke out in Kismayo involving the Ras Kamboni militia and members of a rival miltia, various Somali news sources report
- Fighting erupted when the Raskamboni militia barred tribal militia leader Iftin Hassan from meeting with Somali Defence Minister Abdihakim Haji Mohamud Fiqi.
- Two people died and two were injured

- The spokesman of the Raskamboni militia group Mr. Abdi Nasir Serar talking to BBC said that the fighting in Kismayu is between Alshabab and his group the Raskamboni.
 - Mr. Serar said that they will end the fighting once they wipe out the Alshabab Islamists out of the region.
 - The fighting broke out on June 7th when two self-appointed "presidents" of the southern Jubaland region battled against each other
 - Troops loyal to Ahmed Mohamed Islam (Ahmed Madobe) attacked Iftin Hassan Basto who also claims to be the president of the region.

- Bot Abdulle Magan who served in the transitional parliament alleged that Farole and Ahmed Madobe (a former Islamist leader who is now the leader of Raskamboni militia group) were planning to sell valuable national resources to Kenya and other foreign countries.
- The Puntland leader recently announced his support for Ahmed Mohamed Islam (Ahmed Madobe) as the president of Jubaland. The federal government has rejected the claim and termed the self-election as illegal according to the federal constitution

- The violent standoff broke out on Friday (June 7th) after Raskamboni militias loyal to Sheikh Ahmed Mohamed Islam Madobe reportedly barred militia leader Iftin Hassan Basto from a meeting with Somali Defence Minister
- On Sunday, Kismayo's traditional elders were able to broker a cease-fire between the warring factions, ending the violence and returning city to relative calm,
- Raskamboni spokesman Abdinasir Serar blamed the federal government for meddling and supporting former warlords in the region.
