Hudur Recaptured From Al-Shabaab

• On March 24, after the withdrawal of Government and Ethiopian forces from the Town of Hudur and the subsequent Al-Shabaab takeover, Somalia troops had recaptured the Bakool regional capital

Somali Provincial Leaders Fear Wider Ethiopian Pull Out

- Ethiopia's withdrawal from the Hudur region is causing fears that Al-Shabaab could make territorial gains in other areas
- Ethiopian troops began supporting AMISOM in 2006, withdrawing in 2009 and returning in 2011 on a short-term basis
- According to Osman Libah, a parliamentarian representing the Bay and Bakool regions, the Somali government lacks weapons, technical ability and adequate supplies to compensate for a premature Ethiopian departure
- Director General in the Ministry of Interior and National Security Hussein Abdi Adam said a joint military effort is still the best way to ensure security, since the Somali government was until recently unable to arm itself due to the United Nations arms embargo, which was partially lifted this month
- AMISOM is confident that there are sufficient troop levels in the Bay and Bakool area but noted that AMISOM cannot cover all of Somalia
- The only long-term solution, Mogadishu University Professor Abdulkarim Daud says is "the government building up its forces so that there is no longer a need to depend on foreign troops"

- Marka Major Henry Obba told Shabelle radio that Mohamed Abu was killed during a raid at the lower Shabelle region yesterday
- Abu's role was commanding the Al-Shabaab militia groups in the Bay and Bakool region
- Mr. Obba also noted that the commander was killed 70 km away from Mogadishu and that the security situation at the lower Shabelle region was improving

Somalia: Protect Displaced People At Risk

- HRW released an 80-page report titled "Hostages of the Gatekeepers: Abuses Against Internally Displaced in Mogadishu, Somalia" detailing serious human rights violations including physical and sexual attacks, restrictions on movement, food and shelter and clan-based discrimination against the displaced in Mogadishu
- Over 75,000 IDPs (Internally Displaced Persons) arrived in Mogadishu in 2011 after a famine caused by unrelenting drought, ongoing insecurity and the blocking of civilian access to humanitarian assistance by al-Shabaab
- The most serious abuses were committed by various militias and security forces, often affiliated with the government. These militia groups were linked or controlled by managers, or *gatekeepers* as they are known in the IDP camps
- These gatekeepers determine the location of settlements, the access of IDPs to these settlements and, often, their ability to access humanitarian assistance
- Several women interviewed described being raped, but with little access to or trust in the judicial process, they often do not report these crimes
- Particularly troubling, is the fact that these violations were aided (rather than inhibited) by the withdrawal of al-Shabaab from Mogadishu, creating a vacuum that the then-Transitional Federal Government was unable to fill. This vacuum allowed clan and freelance militias to resurge
- A UN official described the authorities' denial that rape was occurring as the biggest obstacle to tackling the abuse
- Key recommendations include: ensuring police are competent and trained, appropriately disciplining/prosecuting perpetrators of these crimes, collaborating with UN Resident and Humanitarian Coordinator in a profiling exercise of the displaced population and supporting an enlargement of the UN Office of High Commission for Human Rights

- "I and The Federal Government of Somalia welcome the Human Rights Watch for their detailed and comprehensive report into the situation faced by IDP's in Mogadishu in 2011/12. The personal testimonies are heartbreaking and deplorable and totally unacceptable to the values of the Somali people" the President said
- "The decision to establish the Independent Task Force on Human Rights, which was launched on 5 February, was taken to address concerns about the human rights abuses and to investigate violence against women. We fully comprehend the collective responsibility to prevent human rights abuses"
