• Plans are at an advanced stage between Kenya and Uganda to hold a joint disarmament exercise at the borders in order to improve security in the region. The goal would be to end the problem of the currently increased proliferation of arms.

• The Kenya Anti-Corruption Commission (KACC) revealed that the country has been exposed to serious threats by corrupt security, customs and clearing agents

at the Mombasa Port. It was added that the senior officials at the Kenya Revenue Authority work in cooperation with clearing agents at the port and clear imported containers without verifying the content. Six suspect containers imported from China and Dubai were seized on October 12th by the KACC and remain in its custody.

He also urged Kenyans who had not surrendered illegal weapons to do so adding that those found with fire arms will be arrested and taken to court.
