"Kenya reportedly set to harness nuclear power"

Chief Executive of the National Council for Science and Technology Shaukat Abdulrazak said Kenya's first national policy on nuclear energy will be published soon. Setting up the commission will be a big step for Kenya as it prepares to present its case to the International Atomic Energy Agency for approval. Abdulrazak also said that study tours will be conducted in order to come up with an implementation mechanism.

PM Odinga appealed to Kenyans to remain united as the Ocampo Six face formal charges tomorrow. He emphasized the need for the country to reflect and heal past wounds. Starting Friday, prayers will be held countrywide for the victims. Odinga assured the international community of Kenya's security and stability.

Ocampo said that he "has the evidence" against the six individuals accused of post election violence. He said that the violence was "planned" and expressed confidence that he will prove his case. Kenya will be an "example" to the rest of the world.

Nobel Laureate Wangari Maathai called for the phasing out of atomic power reactors and abolition of nuclear weapons globally. A statement issued with 49 other laureates of the Right Livelihood Award and members of the World Future Council cited the hazardous nature of nuclear material to humans and the environment.

"Feuding parties plan rival meetings" by Peter Leftie

Members of the PNU and ODM political parties claimed to have permission to hold prayer rallies at Uhuru Park although police say they have no knowledge of any rallies. PNU supporters declined to say which of the Ocampo Six will turn up even as it became apparent that most of the suspects may stay away following the ICC's warning against making inflammatory speeches. Government Spokesman Alfred Mutua said ODM deputy party leader Musalia Mudavadi had been asked to prevail on supporters not to disrupt the homecoming rally for the Ocampo Six. He accused the party of playing dirty politics.

"African states threaten to leave ICC" by Walter Menya

The AU will consider withdrawing from the Rome Statute en masse should Kenya's request for deferral fail. Chairman of the AU Commission, Jean Ping said that the ICC has double standards. IGAD also hinted at a mass withdrawal.

"Al-Shabaab recruits 'a security threat'" by Galgalo Bocha

Police Commissioner Mathew Iteere said that the recruitment of Kenyan youths by Al-Shabab is a serious security threat to the country. Dozens of women from Mombasa, Kwale and Kilifi counties held demonstrations to condemn the recruitment of their sons into the terror group. Iteere also revealed that police department had acquired three new marine patrol boats to bolster the fight against trade in illicit drugs.

As plans get under way for what organizers term a Grand Reception for the Ocampo Six, dissenting voices to the reception are increasing with the main argument being that the plans go against the ICC process. US ambassador Michael Ranneberger, COTU Central Organization of Trade Unions (COTU) Secretary General Francis Atwoli and Justice Mutula Kilonzo are among those opposed to the plans.

Hellwig asked that Kenya fast track its reform agenda and also establish a local tribunal to try other perpetrators of post election violence who have not been targeted by the ICC. She challenged the media to self-regulate and ensure statements that incite tribal passions will not be broadcast.

MPs led by Deputy Prime Minister Uhuru Kenyatta and Eldoret North MP William Ruto postponed plans to launch a new political party until next year. Dujis MP Aden Duale said it could be premature to launch the party before expected political realignments shape up.

"Kenyans in Netherlands to hold demos over plight of post-poll victims"

Kenyans living in the Netherlands are planning to hold another round of demonstrations to show solidarity with victims of post-election violence. The protesters are annoyed with MPs who accompanied the Ocampo Six to The Hague while victims were forgotten. They are also

unhappy with the government's failure to address the plight of the victims four years after the violence.

Separately, Central Kenya MPs Association Chairman Ephraim Maina and ODM Chief Whip Jakoyo Midiwo pleaded with MPs to embark on a national reconciliation and healing effort. Maina asked MPs to ensure parliament fast-tracks reform bills key to the establishment of a credible judiciary and police force.

Ocampo ordered the six to provide, under oath: their financial statements, bond of personal security, contact information including telephone and e-mail addresses, as well as a commitment to appear at The Hague at least once every six months. If Ocampo has his way, the six will need to vow not to make statements that can be interpreted as threats to potential witnesses nor tamper with prosecution evidence. Due to the senior positions held by Uhuru, Muthaura and Ali, Ocampo wants a gag order to prevent the three from making public statements regarding the case. The ICC instructed lawyers representing the Ocampo Six to contact ICC's Victims and Witness Unit before approaching a witness.

"Kenyan radio audience expresses hopes, doubts over new political alliance"

Uhuru and Ruto forged an alliance promising to run against Odinga in the 2012 election. When asked if the alliance will last, viewers were more or less equally divided between those who feel that the coalition has a future and those who believe that it's solely based on their common predicament and therefore will not endure. Others were very suspicious, especially about Ruto.

"Government drops plan to resettle IDPs in Mau Narok" by Cyrus Ombati and Vincent Mabatuk

According to Internal Security Minister George Saitoti, the disputed land of Mau Narok will now be used for agricultural research. Professor Maitemei Olol Dapash accused the government of arm twisting the community by including non-Maasai people in re-settlement talks. Dapash demanded the immediate removal of security agents as well as the cessation of surveying and demarcation of the Rose Farm. The government is appealing for new land offers from the public.

Sang confirmed that the ICC ordered him to declare his wealth and provide supporting documentation. *The Standard* couldn't confirm if Ruto and Kosgey received similar requests. Sang added that the court ordered him to declare his relationship to those who donated money to fund his trip to The Hague. Following a request, the ICC offered him legal help.

"Tears as Ruto, Kosgey, Sang leave for The Hague" by Augustine Oduor

Sang was the first to arrive, hugging his wife, friends and relatives. Kosgey arrived to a warm reception from several MPs and friends. When asked to speak to the media he said "I am going to The Hague, relax." The crowd held a brief moment of prayer for Ruto with shouts of "rais talk to us" (president, talk to us) filling the air. Ruto said going to The Hague is an opportunity for him to set the record straight. Several MPs gathered earlier at the city Cabanas resort for a brief meeting.
