- Lands Minister James Orengo told a media workshop in Nairobi that the controversy over witnesses who gave false evidence to the Kenya National Commission on Human Rights- KNCHR on the post-poll violence will not deter the International Criminal Court from probing senior politicians and government officials. He added that the government was ready to offer all the necessary support to the ICC to prosecute the instigators of the post election chaos in order to end the culture of impunity. As of the ICC, it had indicated that it was currently interested in inquiring at least five Provincial Police chiefs and PC's who were in office before and during the post election violence.
- The Kenya government has been urged to relocate the Somali refugees living in overcrowded camps in Daadab. According to Médecins Sans Frontières (MSF), at least 700 Somali families are living in harsh conditions in settlements located outside the overcrowded refugee camp Dagahaley, one of the three refugee camps set up in the early 1990s in Dadaab, Kenya, to house Somali refugees. Originally built to accommodate 90,000 people, the camps are today struggling to deal with close to 300,000 refugees. Joke Van Peteghem, MSF's head of mission in Kenya, called the Kenyan authorities and aid actors to facilitate without delay their relocation to proper accommodation.

 Kenyan Prime Minister Raila Odinga is traveling to India for a meeting of the World Economic Forum in New Delhi, India. In his statement, Kivyaso expressed the Council's desire to see the coastal strip autonomous from Kenya and turned into the Republic of Mombasa.

 Security officers have been sent to Mt Elgon (western Kenya) to hunt for more than 50 armed people believed to be members of the re-emerging outlawed Sabaot Land Defence Force. Witnesses said the members of the militia were wearing jungle uniform similar to that of the Ugandan People's Defence Forces and were armed with guns. The militia was crushed by the army two years ago after having caused the death of more than 1,000 people and displaced 50,000 others.
